### Instructions for determining the Most Improved Golfer

Add 12 to the player's Handicap Index at the start date. This value is A. Add 12 to the player's Handicap Index at the end date. This value is B.

Divide value A by value B, calculating to three decimal places. This is the improvement factor. The player with the highest improvement factor should receive the most improved player award.

Example:

Starting Handicap Index: 24.3 | Ending Handicap Index: 16.2

Value A: 24.3 + 12 = 36.3 | Value B: 16.2 + 12 = 28.2

A / B: 36.3 / 28.2 = 1.287

Improvement factor: 1.287

Section two of our journey through the rules is **Taking Relief**.

The first topic will be taking free relief from Abnormal Course Conditions / Embedded Ball.

Certain conditions are not treated as part of the challenge of playing the course, so free relief is provided as an option. This includes interference from temporary water, ground under repair, animal holes, and immovable artificial objects (such as cart paths and sprinkler heads). All of these things are collectively known as abnormal course conditions. You get free relief when the conditions interferes with your lie, stance, or area of intended swing. When an abnormal course condition only interferes with your line of play, free relief is not provided.

To take free relief, you first have to find the nearest point of complete relief, which is the spot on the course nearest to where your ball lies, but not nearer the hole, where you could play your next stroke with no interference from the condition you're taking relief from. Then drop a ball within one club-length of that point not nearer the hole.

If your ball is stuck in the ground (embedded) anywhere except in a bunker or a penalty area, you get free relief. Your ball must be found to take free relief.

Here are some of the most frequently asked questions from our members:

I have interference from an out of bounds fence, stake or wall - what are my options?

You do not get free relief from objects that define or mark the course boundary. You may not move objects marking course boundaries or take free relief from them like you would from other artificial objects, like a cart path, a building, or a stake marking a penalty area. Your options are to play your ball as it lies, proceed under penalty of stroke and distance by playing again from the spot of your last stroke (see Rule 18.1), or decide your ball is unplayable (see Rule 19.1).

My ball is in ground under repair - what are my options?

You may either play your ball as it lies from the ground under repair or take free relief. To take relief, you must find the nearest point of complete relief from the ground under repair and drop your original ball or another ball away from the ground under repair and within one club-length of that point not nearer the hole (see Rule 16.1).

I have interference from a cart path, sprinkler head or other artificial object (immovable obstruction) - what are my options?

You may either play your ball as it lies or take free relief. To take relief, you must find the nearest point of complete relief from the artificial object and drop your original ball or another ball away from the object and within one club-length of that point not nearer the hole (see Rule 16.1).

How do I find the nearest point of complete relief and when is it used?

The nearest point of complete relief is used for taking free relief from an abnormal course condition, a dangerous animal condition, a wrong green or a no play zone. It is the estimated point where the ball would lie that is nearest to the ball's original spot, not closer to the hole than that spot, in the required area of the course, and in a position where the condition you are taking relief from doesn't interfere with the stroke you would have made from the original spot if the condition was not there (see Definition of Nearest Point of Complete Relief).

My ball is stuck in the ground (embedded) - what are my options?

You may play it as it lies or take free relief by dropping the ball within one club-length of the spot right behind where the ball is embedded (see Rule 16.3b).

.I think my ball is stuck in the ground, but I can't find it - how do I proceed?

If you can't find your ball within three minutes, it is lost. Because it is lost, you must return to the spot or your previous stroke and play another ball for one penalty stroke (see Rule 18.2b).

To better understand these procedures I would suggest that you make yourself familiar with the following definitions:

## **Definition of -**

### **Abnormal Course Conditions**

- is any of these four defined conditions: Animal Hole, Ground Under Repair, Immovable Obstruction, or Temporary Water.

### **Animal**

- any living member of the animal kingdom (other than humans), including mammals, birds, reptiles, amphibians and invertebrates (such as worms, insects, spiders and crustaceans).

### **Animal Hole**

- any hole dug into the ground by an animal, except for hole dug by animals that are also defined as loose impediments (such as worms or insects). The term animal hole includes: The loose material the animal dug out of the hole, any worn-down track or trail leading into the hole, and any area on the ground pushed up or altered as a result of the animal digging the hole underground.

### **Ground Under Repair**

- any part of the course the Committee defines to be ground under repair (whether by marking it or otherwise). Any defined ground under repair includes both: all ground inside the edge of the defined area, and any grass, bush, tree, or other growing or attached natural object rooted in the defined area, including any part of those objects that extends up above the ground outside the edge of the defined area (but not when such object is attached to or below the ground outside the edge of the defined area, such as a tree root that is part of a tree rooted inside the edge).

### **Immovable Obstruction**

- any obstruction that: cannot be moved without unreasonable effort or without damaging the obstruction or the course, and otherwise does not meet the definition of a movable obstruction.

### **Temporary Water**

- any temporary accumulation of water on the surface of the ground (such as puddles from rain or irrigation or an overflow from a body of water) that: is not in a penalty area, and can be seen before or after the player takes a stance (without pressing down excessively with his or her feet). It is not enough for the ground to be merely wet, muddy or soft or for the water to be momentarily visible as the player steps on the ground: an accumulation of water must remain present either before or after the stance is taken.

Special cases: Dew and Frost are not temporary water. Snow and Natural Ice (other than from frost), are either loose impediments or, when on the ground, temporary water, at the player's option. Manufactured Ice is an obstruction.

### **Embedded**

- when a player's ball is in its own pitch-mark made as a result of the player's previous stroke and where part of the ball is below the level of the ground. A ball does not necessarily have to touch soil to be embedded (for example, grass and loose impediments may be between the ball and the soil).


