Cover Story: The First Horserace of the Year - April 26th 5:00 PM

A long-standing tradition has begun another season. Some summer Friday afternoon, new arrivals to Canyon Lake Golf will be surprised to see dozens of golf carts scurrying around groups of golfers as they play through together. The regulars will tell them it's the horse race, a fast-paced game of team play, all on the same hole at the same time.

From a distance it looks like mass confusion. Up close, it is fun event to watch and participate in.

When I arrived in Canyon Lake in 1996, the horseraces were in full swing. They were being run by a member Dick Lee. In about 1998 Dick told the membership that he was unable to continue his horserace duties and the races would have to be shut down unless someone were to step forward and take over his duties. The horseraces were so much fun that I volunteered to run the races for the rest of the year. That has never ended.



For those of you who don't know what a horserace is, it is a golf game that has 20-60 players compete. Teams are formed, and every team tees off the first hole at the same time. That means there are about 10 -15 balls laying in the first fairway after the start with all the players and maybe 20-50 spectators. So there are maybe 30-40 golf carts out in the first fairway. The game proceeds as an alternate shot game and the score for each team is recorded. Most races are about 4 or 5 holes, although occasionally more and sometimes we go "cross country".

The person who controls all the shots and keeps score is the Marshall. It is a demanding job taking a lot of stamina and golf rules knowledge to do this job. One of our members, Marcus Schonabaum, a multiple club champion usually handles these duties.

After 2 or 3 holes depending on the size of the field, some teams are eliminated, and they are done for the night. In a typical 4-hole race, we play holes 12,13,10,11 finishing in front of the country club deck. There is an entry fee collected from each player and the 1st, 2nd and 3rd place teams share this money. We also run a pari-mutual so all the participants and spectators can make a wager on the team or teams they like, much the same as at Santa Anita. The payout holds out a certain percentage of the pot for use in supporting the golf club and individual tournaments.



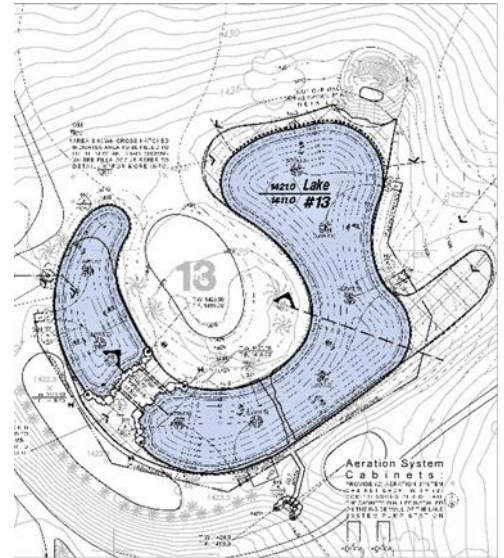
We usually have a race every 2 to 4 weeks, depending on scheduled tournaments and POA events. All in all, the typical horserace lasts 1.5-2.5 hours. The participants and spectators usually gather in the Country Club afterwards for drinks, dinner and camaraderie.

Watch for the email announcements. Sign-up your group to play or place your bets in the Magnolia Room before the 5:00 PM start and join the crowd when the play begins.

News and Information Restoration of the Lakes on 13

A final design has been selected and the construction drawings and specification are complete. The image to the right shows the configuration. Blue represents the outline of the new lakes and the cross hatched areas represent the parts being filled in. The bridge is being replaced by an earthen walkway with boulder wall borders. The green rough will now slope to the lakes or to short boulder walls at selected locations. The Green Committee has participated in the selection and commented on the design. It looks great – can't wait to see the finished product and enjoy full lakes again!
The Request for Bids is being prepared and it is expected that the project will go before the POA Board in July, after the bids are received, for final funding approval. The suggested November 2019 completion is in sight.



CARTS Greens and Fairways



Obey all posted limits on Golf Cart access to the fairways and markers showing the boundary when approaching the greens. Avoid driving near wet areas such as on 1, 5 and 16.

Golf Carts must always be kept 15 yards from the greens, even for our handicapped golfers. Stay on the Cart Paths whenever possible

Unless otherwise posted, the 90-degree cart rule is always in effect. All par 3's are cart path only.

If you see a violator, remind them politely about the rules and let our Marshall know. The fairways, greens and surroundings are fragile. We must protect them to maintain the integrity of our playing surfaces.

Happy Birthday to TWG's Hub Watson

Born in 1924, Hub had recently turned 95 and is still a regular on the beverage cart – delivering water to the workers and donuts to the Tuesday morning lady golfers. Getting to Know Steve Schneider, Director of Canyon Lake POA Operations By Ted Horton, CLMGC Secretary

His education and previous work experiences have resulted in a highly self-directed individual adapted to the multi-tasking and problem solving demanded by POA Operations. A first look at his resume and list of accomplishments makes me feel that we are lucky to have him on our team.



When I asked him what caused him to pursue a career in Canyon Lake Operations he noted that *“he was looking for a change of pace presenting more diversity than daily repetitive engineering tasks. POA Operations is anything but repetitive and boring and he has found an outlet for his life-long skills of building and project management”*. These skills have immediately been put to work at the golf course where Steve noted that *“about half of his efforts at the golf course have been focused on problem solving”*. He noted *“that the lake and irrigation system has been a baptism by fire for him”*.

We discussed workplace demands, how he approaches and solves problems by planning in advance and the use of available resources. *“The most pressing challenge is the age of our community and its amenities. Stressed by time or outdated by change, many of the facilities need to be updated or replaced”*. The good news is that the POA and its Directors and Management are financially capable and motivated to address needed improvements. He views the recent

booster pump project to bypass the 13th hole irrigation pond as a source of water for greens was a positive project with significant financial return on the investment. When I asked what golf project has been a disappointment to him, *“he quickly expressed his frustration with the road blocks keeping us from converting from potable to recycled water for irrigation of holes 3, 4 and 5”*.

Steve noted that the Operations Director needs to be well-networked with government agencies and local construction and supply companies. His previous experiences have enabled interaction with the POA Committee leaders and city management. *These are important relationships due to the ever-changing nature of the Operations Department work demands*. He enjoys working with Mark Louder and BrightView Golf Course Management and is usually not burdened with their challenges. He has found the Green Committee to be thorough in its suggestions and TWG is appreciated for the myriad of small projects accomplished without burdening Operations. Steve appreciates the open communication amongst all of the concerned parties.

Leading employees appropriately is critical to accomplishment of community goals. Mentoring, identifying skill gaps, strengths and weaknesses of his leadership team and special project management personnel is especially important to Steve. *“Never ask an employee to do a job you wouldn’t do yourself”* is his motto. Employee situations, good or bad, need to be faced appropriately every day to keep the “stress level” as low as possible. If a situation might boil over Steve immediately attempts to lighten up the situation. *“It’s important to see that employees have all they need to resolve issues when possible”*. Gratification comes from getting the jobs done but delays definitely get under his skin. *“It’s important to always have a plan B, or C in the works – just in case!”*

To stay at the top of his game, Steve has been taking Fred Pryor Certification classes on line along with 10 other POA Managers. A wide range of classes are offered such as Handling Difficult Employees; Project Management; and, various computer skill improvement courses. Steve is hoping to become California Association of Community Manager Certified (CCAM) this year, joining GM Eric Kasakoff, Director of Member Services Cory Graham and Executive Assistant Harmony McNaughton who are currently certified.

The Operations Director is in charge of overseeing budgets and financials in one of the POA’s largest departments. Deployment of funds with fiscal discipline, attention to Reserve and Capital Projects and accountability to the General Manager and Community on the use of funds is important. It is critical to keep projects on budget and on point. Strategic thinking relative to the short and long range well being of the community is important and with POA solvency, he appreciates the opportunities to address many of the costly needs throughout the community. It’s no surprise that he is finding that tightening environmental and water restrictions are affecting the community. It is a challenge to stay up to date on issues and adapt as necessary.

Steve doesn’t play golf but assured me that he hopes to take advantage of Director of Golf Pat Kembal’s offer of a couple of lessons soon. So, what does he do to relax? He has always worked on cars, hangs out with family and really enjoys the opportunity to sail his 30 foot Catalina on the San Diego waters.

Thanks for your efforts in Canyon Lake Steve. We all appreciate the results.

April 3, 2019 Minutes**

Call to Order: President Jon Evans called the meeting to order at 1:30 PM and led the Pledge of Allegiance.

Attendance: Present were President Jon Evans, 2nd VP Chuck Newsom, Directors Greg Brack, Rick Halsey, Ted Horton, Chris Poland, Tom Scudieri, Rod Smith & Jerry Watson. Absent was 1st VP Chris Wilkeson. A quorum was present. Six (6) members attended.

Approval of Minutes: It was moved Treasurer Smith, seconded by Director Halsey and approved **“to accept the March 6, 2019 meeting minutes as submitted”**.

Director of Golf Report: Pat Kemball – Absent, no report.

Golf Course Superintendent Report: Mark Louder – Absent, no report.

SCGA Liaison Report: Dudley Thompson – absent – no report

Secretary's Report: Ted Horton reported:

All correspondence is current and all supplies are on hand.

- Get well cards in March: Jordan Ehrenkranz – hospitalized; Sam Theodora – medical setback.
- Sympathy cards in March: None

Action Items: None

Treasurer's Report: Treasurer Rod Smith presented his report, noting that:

- Membership anniversary dates have now been obtained that will permit him to project dues income on the rolling monthly basis. The CLAPPS Beautification Tournament and Team Play have been paid this year. About 36% of the budgeted celebrations of life have been expended.
- Money has been collected from all but two sponsors.
- The club bank balance as of March 31, 2019 is \$29,167.83 but we owe SCGA approximately \$23,000.00.

- Perform financial audit – President Evans, Treasurer Smith, Secretary Horton, Director Poland
- Change bank signatures

It was moved by Director Halsey, seconded by Director Watson and approved **“to accept the Treasurer's report as submitted.”**

Handicap Report: Rick Halsey reported:

During the month of March 2019: 42 indexes went down; 84 remained the same; 78 went up; 2 members have no index; 8 members have a local index (over 36.4); and 2 members have reduced indexes. 855 rounds were posted by 204 members; 6 cards had no date; 2 cards had a first names only.

Director Halsey noted that when he compared “rounds posted” with “rounds played from proshop records”, he found significant discrepancies – 57 proshop rounds resulted in only 6 score cards posted. Offending individuals have been spoken to.

Mark Lauder: Golf Course Superintendent

Greens are being verticut weekly. Rabbits are causing damage on holes # 4 and #5.

There are several areas of drainage issues, especially on holes 4 and 5. These are being corrected

Bunkers: The committee would like to hear from the golf club members as to whether the rakes should be left in the bunker or out of the bunker. The new rakes are here but continue to be broken. Roots that have grown in the bunkers are being removed. Let us know if you notice any further root growth and Mark will have them removed.

The left side of # 10 green is improving and the new sod is starting to grow

The lake continues to drain despite the large amount of rain we have had this year. The rains did remove a good portion of the growth in the ditch.

Wood chips are being added in the drought tolerant areas as needed.

Phil Hawgood: POA Liaison

The parking lot repairs are still on track to begin in October, hopefully when the course is closed.

Pat Kemball: Golf Course Professional

Pat presented the local rules to the committee. A motion was made and carried, that we accept these rules. They will be printed on the new score cards. Let Linda know if you are not aware of the new rules.

We have lost some of the 'outside members' due to moving or the increase in fees. The POA is marketing the local communities to increase the 'outside membership'.

Salvador Medina and **Steve Schneider:** Operations

The drought tolerant areas are being cut back and dead plants removed.

Steve presented a plan for the lake. This will go to the POA for approval.

TWG: **Don Norris** reported 'the wall' should be completed by the end of March. Then the POA will begin widening the cart path.

Mulching is continuing in the drought tolerant areas as needed.

Linda Kamashian asked that the brush at the bottom of hill on 17 be cleared so the balls won't get stuck in the bushes. She also mentioned the shorter hitters would like the rough in front of the greens cut back so there would be more fairway to work with. She also wanted to know if the ditches could be kept clean now that the rain has cleared them out. **Valerie** explained that it is an environmentally protected area and we are not allowed to clean it, we would be subject to a large fine, etc. She mentioned that the water gathering under the bridge is being blocked by the brush and the water looks stagnant. She will ask Mark to at least open it up so the water can flow through.

Valerie said the BrightView contract expires May 1. They need an RFP. A group of four from the Green Committee went through the existing contract making changes or additions starting in October. They are still awaiting an RFP from the POA. If it is allowed to expire, they go month to month and we may lose Mark. Mark would like to stay and he would also like to take care of the drought tolerant. It was suggested we bring that up on Speak to the Candidates night.

Sunshine **Lila Gann:** No report . .

SB&R **Darlene Cortez:** We played at Jurupa , Six ladies went and five won. The next one is at Seven Hills.

CLIPPS: **Valerie Montgomery:** CLIPPS are Working on the Senior Tournament.

Old Business:

Outside membership. **Ura** mentioned that she brought up having outside members last year to increase our membership They would not have to be annuals. They would just join our club and play only on Tuesdays and in our events. Our Canyon Lake clubs can have 40 percent outside members. 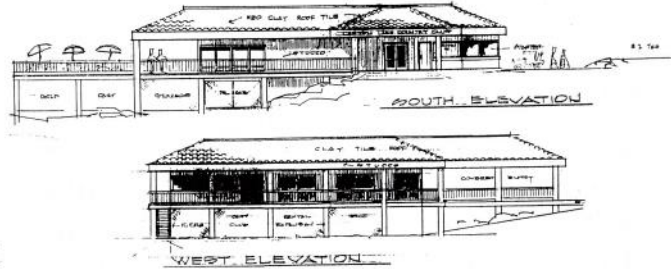
